**Details:**

On 8/24/11 as part of an ongoing investigation into the sales of narcotics in and around the Lincoln Oval area, officers from the Visalia Police Department's Narcotic Unit conducted a traffic stop and a follow-up search warrant. During the traffic stop, officers located 8.8 grams of methamphetamine on (S) Vasquez's person, who was the passenger in the vehicle. (S) Burros, who was the driver of the vehicle, was in possession of two syringes and a small quantity of methamphetamine. A search warrant was conducted at (S) Vasquez's residence in the 300 block of North Granite, where officers located an additional 2 grams of methamphetamine, currency, packaging material, and a digital scale. Some of the methamphetamine located in the residence was in the room belonging to (S) Soto and was accessible to her two children.

(S) Vasquez was booked into the Tulare County Jail for possession of methamphetamine for sales, transportation of methamphetamine, maintaining a residence where narcotics are sold, and child endangerment. The case has been submitted to the Tulare County District Attorney's Office for charges against (S) Burros possession of methamphetamine and possession of syringes; as


