Details: On 11-4-11 at approximately 1500 hours officers from the Visalia Police Department Gang Suppression Unit, with the assistance of the Narcotics Unit conducted a search warrant for Narcisso Frank Sedillo and his residence at 1700 W. Harold. During the course of the search warrant, approximately 4 grams of Methamphetamine, digital scales, packaging material and a large amount of US currency were located, all of which is consistent with narcotic sales. A stolen firearm and several different types of ammunition, along with a large amount of gang indicia were also located at the residence.

During the course of search warrant GSU officers located several items that were believed to have been taken in recent burglaries and requested the assistance of detectives from the Property Crimes Unit. Through investigation the Property Crimes Unit and GSU officers were able to return over \$7,900.00 worth of property within hours of the completion of the search warrant. There is still a large amount of electronic equipment and jewelry that detectives are attempting to return to owners.

Narcisso Sedillo was booked at the Tulare County Main Jail for charges that include possession of methamphetamine for sales, maintaining a residence for sales of narcotics, possession of drug paraphernalia, possession of stolen property, possession of a firearm during the commission of a felony, possession of a controlled substance while being in possession of a firearm and felony gang enhancement


