Details: On 1/20/11 at approximately 1635 hours, officer from the Gang Suppression and Narcotics Unit served a search warrant at 2040 W. Robin. During the search, 5 ounces of Methamphetamine, 1 ounce of Cocaine, approximately 5 pounds of Marijuana, and a large amount of Soma and Vicodin were located. The above individuals were booked into the Tulare County Jail for the above violations as well as maintaining a residence for narcotics sales, weapons violation, and resisting arrest. The estimated street value of the seized items is over \$10,000.
