Details: On 1/30/11 at 0223 hours Visalia Police Officers responded to the area of Giddings and Walnut for a reported stabbing. Upon arrival officers made contact with the two listed victims who were both suffering from stab wounds. During the course of the investigation officers learned that the victims had been at a party in the 2100 block of S. Conyer. Officers then responded to the location of the party. Upon arriving at this location officers located the above listed suspect who was detained. Further investigation revealed that Jose Jimenez had stabbed that two victims during an altercation. Jimenez was booked into the Tulare County Jail for two counts of attempted murder (664187 P.C.)

Both of the victims in this case were transported to KDMC and admitted for treatment of non-life threatening stab wounds to the upper body.
