Details: On 02/06/11 @ approximately 0257 hours, Patrol Officers responded to an Apartment on the 4700 block of W. Douglas and contacted the Victim. (V) Mitchell was transported to the hospital for treatment of a single stabbing injury to his neck. Witnesses at the scene stated that (V)Mitchell and his girlfriend were engaged in a physical altercation when an unknown Black Male Suspect entered the apartment and stabbed (V)Mitchell in the neck. The Suspect then exited the apartment and left in an eastbound direction.
