- 1. An agency authorization from the Nonprofit designating an Agent (person to be issued the Permit).
- 2. A current copy of the nonprofits agency's 501(c) status.
- 3. A list of the location(s) of the sign(s) including addresses or APNs.
- 4. A picture or drawing of the sign including dimensions and content of the sign.

 The sign must clearly indicate that the named nonprofit organization is sponsoring the event.

Applications without items 1 through 4 are deemed incomplete and cannot be accepted for submittal.

The following regulations pertain to sign placement:

- 1. The sign must clearly indicate that the named nonprofit organization is sponsoring the event.
- 2. One sign per site/parcel.
- 3. The sign(s) shall not be placed in any public-right-of way (Public Right-of-Way is typically 10-11 feet behind the face of the curb).
- 4. Signs may not be attached to trees or other landscaping, fence posts or utility poles.
- 4. Signs shall not obstruct sight line visibility at drive aisles, streets or intersections.
- 5. Signs must be removed no later than 7 days following the event.
- 7. Must comply with all local, state, federal laws, rules, conditions and regulations.
